Have a safe and a happy holiday season.

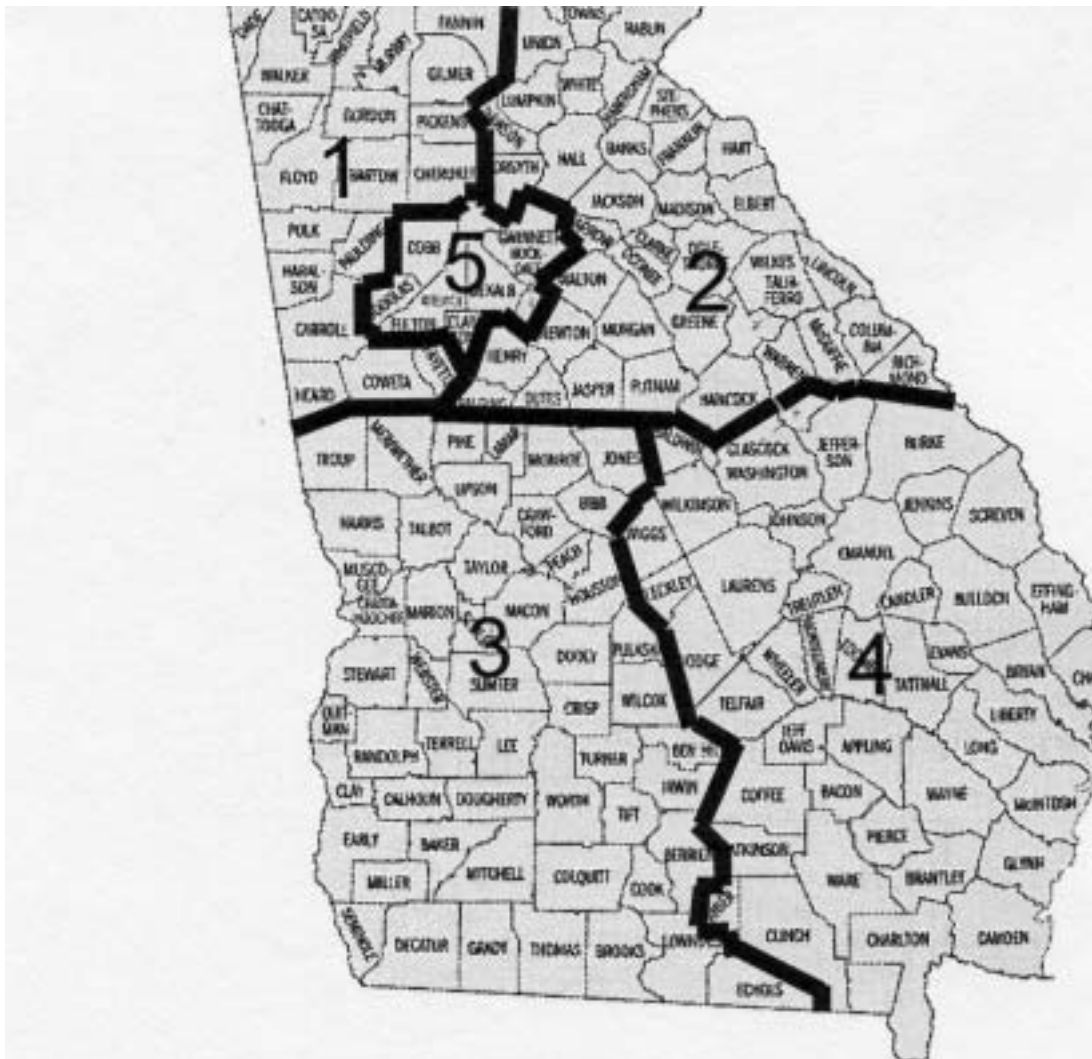

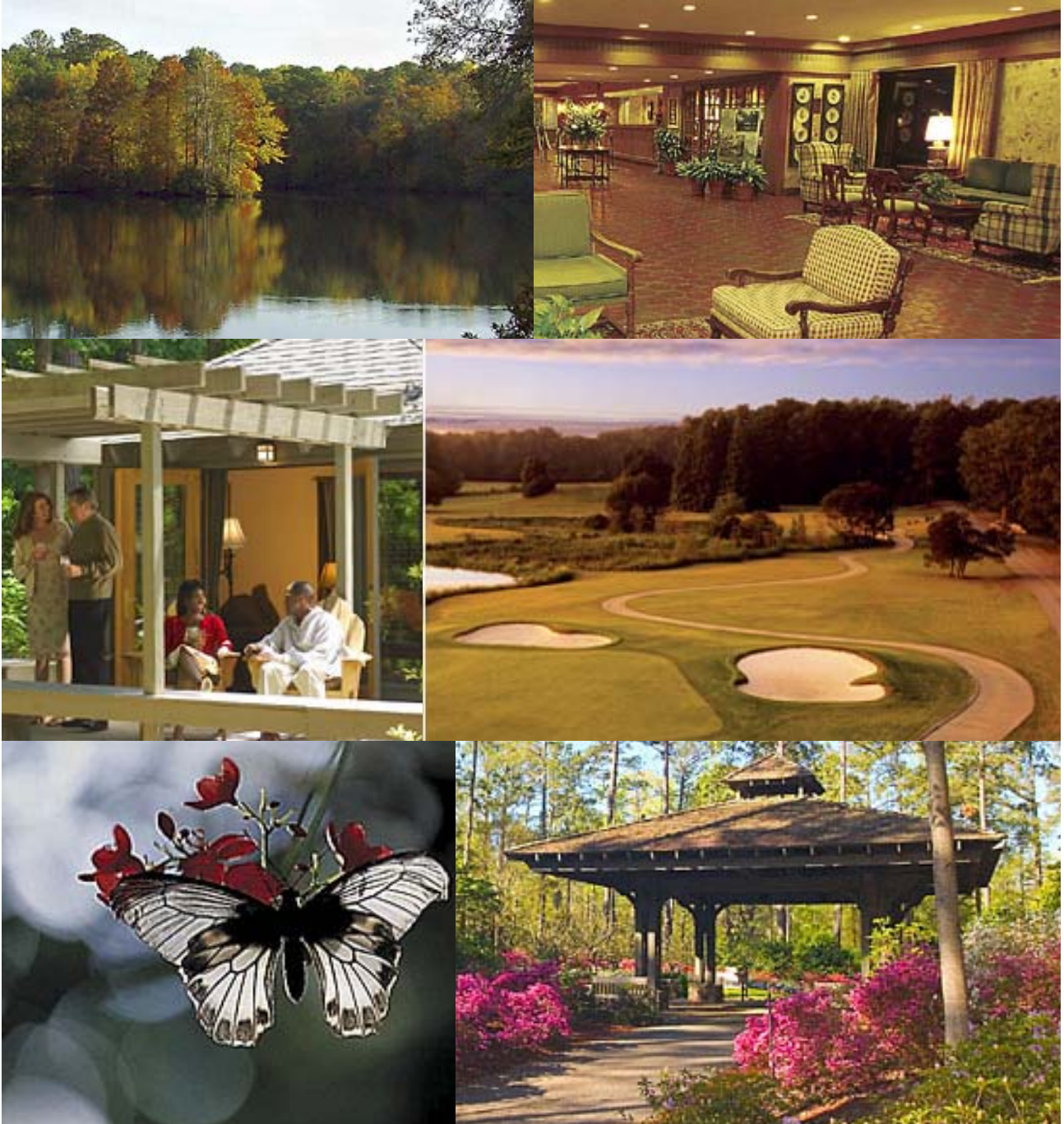
